Ms. A. Rohan, Meetings Administrator commenced the meeting with a statement of intent to conduct the business of the meeting in line with Standing Orders followed by a moment of silent reflection.

Deputy Mayor N. McNelis welcomed all attendees and referred Members to agenda item 1 and invited comments.

2. Confirmation of Minutes

(a) March Plenary Council meeting held on 10th March 2025.

Deputy Mayor N. McNelis referred Members to agenda item 2(a) and invited matters of accuracy or matters arising.

There were no matters of accuracy. Matters arising were as follows:

- Update requested regarding the cost estimates associated with the damage caused by Storm Éowyn.

- Number of social housing tenants currently in arrears and a breakdown of legacy debt.
- Query on the level of use of generative AI for marketing promotion by the City Council.
- Update on public lighting issues following storm Éowyn and communication issued to affected residents.
- Update on MMT report and Christmas Park and Ride.
- Update on pedestrian safety at two ongoing developments on Upper Clybaun Road.
- Update on Pálás Cinema.

The executive responded to matters arising.

Mr. D. Pender addressed queries regarding wall damage resulting from the storm and informed Members that correspondence has been issued to residents with guidance on the appropriate course of action.

Members raised further clarifications as follows:

Cllr. M. Cubbard referred to the correspondence issued to tenants in arrears, specifically noting the prominent red text used, and requested that the wording be reviewed.

Cllr. D. Lyons referred to a previous meeting during which Councillors had requested a list of estates affected by public lighting damage following Storm Éowyn, noting that this information has not yet been received. He further requested that the public be informed of the status of the situation.

Both Cllr. A. Cheevers & Cllr. H. Ogbu expressed concern regarding the lack of communication from the City Council to the public and requested that the Chief Executive prioritise improvements in this area going forward.

Cllr. A Curran requested that the Monthly Management Reports and Quarterly Reports be made more prominently accessible on the website, noting that they would serve as a valuable source of information for members of the public.

Mr. L. Cleary responded that he would examine the possibility of enhancing the visibility of the Monthly Management Reports and Quarterly Reports on the website. He also advised that the Council is currently awaiting sanction from Central Government for additional resources to support the Communications Team.

Ms. H. Kilroy advised that she would review wording on arrears correspondence to tenants.

Deputy Mayor N. McNelis requested that a report be issued to Members on the storm damage costs and public lighting issues.

Mr. L. Cleary agreed to provide Members with a report outlining the issues and challenges, including financial constraints once collated.

Deputy Mayor N. McNelis referred Members to agenda item 4(a) and invited comments. A discussion followed and a number of queries were raised by Members and responded to by the Executive.

Ms. A. Rohan provided an update to the Members regarding the EU Councillors Network advising that up until now there have been two networks, one organised by the Committee of the Regions and the other by Building Europe with Local Councillors (BELC) by the European Commission. These are being merged formally and only one process will be in place in the future. It was noted that Cllr. D. McDonnell currently serves as the spokesperson for Galway City Council on the Committee of the Regions network. The Deputy Mayor requested that this item be deferred to the next meeting in order to seek further clarification concerning the network. This was agreed.

Cllr. D Lyons referred to page 1 and Notice of Motions NOM 02/2025 and NOM 26/2023, noting that he has yet to receive a response regarding the planning permission. Mr. D. Pender advised that he would issue a response to Cllr. D. Lyons by close of business tomorrow.

Cllr. M. Pilot of Accessible Parking Bay Text Alert Scheme: I propose the following motion for consideration by the Chief Executive, Directors and Council Members: That Galway City Council supports the Disabled Drivers Association of Ireland's (DDAI) campaign to combat the abuse of accessible parking bays and commits to implementing a pilot of the Accessible Parking Bay Text Alert Scheme in Galway City. This scheme would allow members of the public to easily report the misuse of accessible parking spaces via a simple text message, supporting better enforcement and protection of parking bays for those who genuinely need them. The pilot could be trialled in key locations across the city where misuse has been identified, with a view to expansion following review and stakeholder consultation.

However, during discussions on the commercial rate increase, I highlighted the importance of reconsidering this decision. With commercial rates now increased, it is crucial that businesses in Wood Quay receive fair treatment, especially compared to those in the West, where outdoor dining is permitted from May to September. The businesses in Woodquay are requesting approval for a much shorter period - only from July to the end of August.

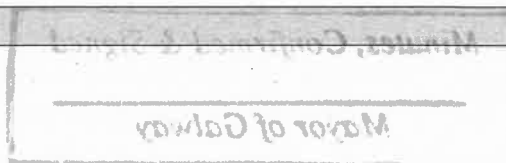
