Clár/Agenda

1. Consideration of Draft Annual Budget 2026 and adoption of Annual Budget 2026 - Circulated 17 November 2025.
2. Determination in accordance with the Annual Budget adopted of the Annual Rate on Valuation to be levied for the several purposes specified in the Annual Budget for the financial year ending 31 December 2026.
3. That Galway City Council considers a scheme for the abatement of rates due to it by liable persons, or classes of liable persons, in respect of vacant properties in accordance with the provisions of Section 9 of the Local Government Rates and Other Matters Act 2019, as amended.
4. To consider the adoption a Commercial Rates Incentive Scheme 1 January 2026 – 31 December 2026, in accordance with Section 66 of the Local Government Act, 2001, as amended by Section 43 of the Local Government Reform Act, 2014:
 - The Small and Medium Enterprise (SME) Scheme – 5% reduction in rates for businesses with rates bills < €30,000 who meet certain criteria
