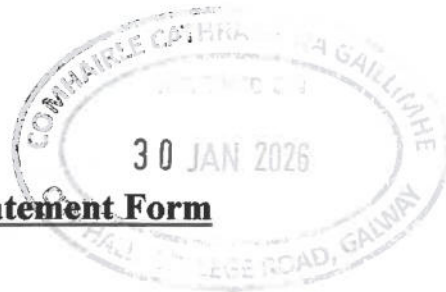

PENALTIES
