PLANNING & DEVELOPMENT ACTS 2000 (AS AMENDED) PLANNING & DEVELOPMENT REGULATIONS 2001 (AS AMENDED) – PART 8

Applicant: Galway City Council – Housing Department
Location: Ballyburke, Galway

Proposal:

In accordance with Part X1 of the Planning and Development Acts 2000 (as amended) and Part 8, Article 81 of the Planning and Development Regulations 2001 (as amended) notice is hereby given by Galway City Council of a proposed social housing development on lands at Ballyburke, Galway.

The development will consist of:

(a) 84 no. social residential units comprising of: (i) 25 no. one-bedroom apartments (ii) 18 no. two-bedroom apartments (iii) 16 no. two-bedroom apartments (Age Friendly Units) (iv) 2 no. two-bedroom apartments (Universal Design) (v) 10 no. three-bedroom apartments (Universal Design+) (vi) 13 no. three-bedroom terraced houses; (b) a new central community/ neighbourhood plaza area; (c) local centre units; (d) café; (e) crèche facility; (f) renewable energy design measures for each unit and (g) supporting development works including (i) access roads (ii) grouped parking spaces; (iii) landscaping; (iv) surface water attenuation tank; (v) temporary construction signage; (vi) estate signage; and (vii) all associated site works.

Plans and particulars of the proposed development will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy for a period of **4 weeks from Thursday, 18th January 2024** up to and including **Friday, 16th February 2024** during public hours at the Planning Office, Galway City Council, City Hall, College Road, Galway, from 9:00am to 4:00 pm Monday to Friday, excluding Bank Holidays.
