**COMPULSORY ACQUISITION OF LAND**  
GALWAY CITY COUNCIL BÓTHAR STIOFÁIN ACTIVE TRAVEL SCHEME COMPULSORY PURCHASE ORDER NO. BSATS-CPO-002, 2024, IN THE CITY OF GALWAY  
An Bord Pleanála on 8th October 2024 advised Galway City Council that the Bóthar Stiofáin Active Travel Scheme Compulsory Purchase Order No. BSATS-CPO-002, 2024 could be confirmed. Galway City Council has, on 12th November 2024, made a Confirmation Order confirming without modification the above-named compulsory purchase order (the "Order") as respects the land described in the Schedule hereto.  
The said Order, as so confirmed, authorises Galway City Council to acquire the land described in the Schedule hereto compulsorily.  
The said Order is necessary for the purpose of the construction of Bóthar Stiofáin Active Travel Scheme in the City of Galway, together with all ancillary works associated therewith, and for the purposes of providing infrastructure to facilitate walking and cycling.

The Order, as so confirmed, will become operative three weeks from the date of publication of this Notice.  
An application for judicial review of the decision of Galway City Council under Order 84 of the Rules of the Superior Courts (S.I. No. 15 of 1986) may be made to the High Court within eight weeks of the date of publication of this Notice in accordance with section 50 of the Planning and Development Act 2000 (as amended).
