

Salthill Parking Study June 2021

Prize Draw Terms & Conditions

7. Winners will receive **one of three prize vouchers for €100**. One prize per person applies.
8. The prize draw is not open to employees of Galway City Council.
9. The Prize Draw will take place in July 2021, following the close of the survey.

If the winner does not respond within 14 days of being notified by GCC, then the winner's prize will be forfeited and GCC shall be entitled to select another winner in accordance with the process described above. This winner will have to respond within 14 days, or they will also forfeit their prize. Téarmaí agus Coinníollacha an Chrannchuir Duaiseanna

1. Is féidir le daoine a fhreagraíonn Suirbhé Páirceála Bhóthar na Trá 2021 ó Chomhairle Cathrach na Gaillimhe cur isteach ar an gcrannchur duaiseanna (an "Crannchur Duaiseanna") má chuireann siad a sonraí teagmhála ar fáil tar éis an suirbhé a chur i gcrích.
2. Measfar gur ghlac na daoine a chuir isteach ar an gCrannchur Duaiseanna leis na Téarmaí agus Coinníollacha seo a leanas.
3. Ní féidir le duine cur isteach ach uair amháin. Ní ghlacfar le hiontráil a dhéantar thar ceann duine eile.
4. Ní ghlacann Comhairle Cathrach na Gaillimhe le freagracht as aon iontráil a chailltear, a chuirtear moill uirthi, a chuirtear ar strae nó atá neamhiomlán, nó nach féidir a sheachadadh nó a iontráil ar aon chúis theicniúil nó eile. Ní hionann fianaise ar iontráil a sheachadadh agus fianaise go bhfuair Comhairle Cathrach na Gaillimhe an iontráil.
5. Is é an dáta deiridh don Chrannchur Duaiseanna 6.00 p.m. **Dé Sathairn 10 Iúil 2021**. Ní chuirfear san áireamh aon iontráil a fhaightear lasmuigh den tréimhse sin.
6. Roghnófar na buaiteoirí go randamach as na hiontrálacha a fhaightear i gcomhréir leis na Téarmaí agus Coinníollacha seo.
7. Gheobhaidh buaiteoirí **ceann amháin de thrí dearbháin duaise do €100**. Ní thabharfar ach duais amháin do gach buaiteoir.
8. Ní féidir fostaithe Chomhairle Cathrach na Gaillimhe páirt a ghlacadh sa chrannchur duaiseanna.
9. Déanfar an Crannchur Duaiseanna i Iúil 2021 i ndiaidh dhúnadh an tsuirbhé.
10. Rachfar i dteagmháil leis an mbuaiteoir ach úsáid a bhaint as na sonraí a chuirtear ar fáil sa suirbhé, i ndiaidh an chrannchuir duaiseanna. Beidh ar an mbuaiteoir sin freagra a thabhairt laistigh de 14 lá. Mura bhfreagraíonn, caillfidh sé nó sí an duais freisin. Má dhiúltaíonn buaiteoir an duais a ghlacadh, nó má tá an iontráil neamhbhailí nó má sháraíonn an iontráil na Téarmaí agus Coinníollacha seo, caillfidh sé nó sí duais an bhuaiteora agus beidh CCG i dteideal buaiteoir eile a roghnú.
11. Ag brath ar na srianta Covid a bheidh i bhfeidhm tráth an chrannchuir duaiseanna, comhaontófar na socruithe maidir le seoladh/seachadadh/bailiú na nduaiseanna leis na buaiteoirí.
12. Téarmaí agus Coinníollacha an Chrannchuir Duaiseanna

13. Ní féidir an duais a mhalartú ná a aistriú do dhuine eile agus ní féidir airgead tirim ná duaiseanna eile a fháil ina háit.
14. Coimeádann CCG an ceart aici duais eile ag a bhfuil luach den chineál céanna a chur in áit na duaise sa chás nach bhfuil an duais bhunaidh ar fáil.
15. Tá an duais/na duaiseanna faoi réir théarmaí agus coinníollacha an déantúsóra nó an tsoláthraí agus beidh feidhm ag gach baránta agus ráthaíocht táirge nó aon léiriú eile i dtaca leis an duais/na duaiseanna faoi mar a sholáthraíonn an déantúsóir nó an soláthraí iad. Ní bheidh CCG freagrach as aon duais(eanna) a bheith neamh-chomhoiriúnach le haon táirge nó seirbhís eile.
16. Déanfar do shonraí pearsanta a phróiseáil i gcomhréir le polasaí cosanta sonraí CCG. Le haghaidh eolais faoi pholasaí cosanta sonraí Chomhairle Cathrach na Gaillimhe, féach anseo.
17. Nuair a chuireann tú isteach ar an gCrannchur Duaiseanna, comhaontaíonn tú le bailiú, coinneáil, úsáid agus scaipeadh do shonraí pearsanta chun críche próiseála agus chun teagmháil a dhéanamh leat faoi d'iontráil sa Chrannchur Duaiseanna, agus chun na gcríoch eile a leagtar amach sna Téarmaí agus Coinníollacha seo.
18. Ní ghlacann CCG le freagracht as aon damáiste, cailliúint, dliteanais, gortú nó díomá a bhaineann leat mar gheall gur chuir tú isteach ar an gCrannchur Duaiseanna nó gur ghlac tú leis an duais.
19. Coimeádann CCG an ceart aici an Crannchur Duaiseanna seo a athrú nó a dhúnadh go sealadach nó go buan, ag am ar bith agus ó am go chéile agus gan fógra roimh ré a thabhairt, mar gheall ar chúiseanna nach bhfuil faoina smacht (lena n-áirítear, gan teorainn, sa chás go meastar go ndéanfar calaois, gurb ann do chalaois amhrasta nó do chalaois i ndáiríre). Is cinneadh deireanach agus ceangailteach é cinneadh CCG i ngach ábhar faoina smacht agus ní ghlacfar le haon chomhfhreagras.
20. Ní bheidh CCG faoi dhliteanas duit má chailleann tú aon rud nó má bhaineann damáiste duit tríd an gcrannchur duaiseanna a iontráil (lena n-áirítear, ach gan a bheith teoranta do, aon chaillteanas indéach, pionósach, speisialta, eiseamláireach, teagmhasach nó iarmhartach, cailliúint bhrabúis, cailliúint ioncaim, cailliúint dea-thola a thagann as páirt a ghlacadh sa chrannchur duaiseanna nó a bhaineann le páirt a ghlacadh) nó mar gheall gur dhiúltaíomar duit páirt a ghlacadh sa chrannchur duaiseanna nó mar gheall gur tharraingíomar an crannchur duaiseanna siar nó mar gheall ar aon teip nó neamhábaltacht a bhaineann leat maidir le páirt a ghlacadh sa chrannchur duaiseanna nó leas a bhaint as ar chúis ar bith.
