

School Streets Survey April 2021

Prize Draw Terms & Conditions



1. The prize draw (the "Prize Draw") is open to respondents (residents/ businesses) in the local area around Scoil Iognáid, Raleigh Row, and parents/ guardians of children attending the school, who provide their contact details after completing the survey.
2. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
3. Only one entry per person. Entries on behalf of another person will not be accepted.
4. Galway City Council (GCC) takes no responsibility for entries that are lost, delayed, misdirected or incomplete, or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by Galway City Council.
5. The closing date for the Prize Draw is 6.00pm on Friday 21st May 2021. Entries received outside this time period will not be considered.
6. Winners of fitness trackers/ tablets will be chosen at random from entries received in accordance with these Terms and Conditions.
7. Winners will receive one of three fitness trackers, OR one of two tablets. One prize per person applies.
8. The prize draw is not open to employees of Galway City Council.
9. The Prize Draw will take place in May/ June 2021, following the close of the survey.
10. The winner will be contacted on details provided in the survey, following the prize draw. If the winner does not respond within 14 days of being notified by GCC, then the winner's prize will be forfeited and GCC shall be entitled to select another winner in accordance with the process described above. This winner will have to respond within 14 days, or they will also forfeit their prize. If a winner rejects their prize, or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and GCC shall be entitled to select another winner.
11. Depending on Covid restrictions in place at the time of the prize draw, arrangements for posting/ delivery/ collection can be agreed with the winners.

Téarmaí agus Coinníollacha an Chrannchuir Duaiseanna

1. Tá an crannchur duaiseanna (an “Crannchur Duaiseanna”) ar oscailt do fhreagróirí (cónaitheoirí/gnóthais) sa cheantar áitiúil timpeall Scoil Iognáid, Bóithrín na Sliogán, agus do thuismitheoirí/caomhnóirí leanaí atá ag freastal ar an scoil, a sholáthraíonn a gcuid sonraí teagmhála tar éis dóibh an suirbhé a chomhlánú.
2. Measfar gur ghlac iontrálaithe sa Chrannchur Duaiseanna leis na Téarmaí agus Coinníollacha seo.
3. Foirm iontrála amháin an duine. Ní ghlacfar le hiontráil thar ceann aon duine eile.
4. Ní ghlacann Comhairle Cathrach na Gaillimhe (GCC) aon fhreagracht as iontrálacha a chaillfear, a gcuirfear moill orthu, a mhíthreorófar nó a bheidh neamhiomlán, nó nach féidir a sheachadadh nó a iontráil ar chúis theicniúil nó ar chúis ar bith eile. Ní cruthúnas go bhfuair Comhairle Cathrach na Gaillimhe an iontráil cruthúnas ar sheachadadh na hiontrála.
5. Is é an dáta deiridh don Chrannchur Duaiseanna 6.00pm ar hAoine 21ú Bealtaine 2021. Ní bhreithneofar iontrálacha a fhaightear lasmuigh den tréimhse ama seo.
6. Roghnófar buaiteoirí na rianairí corpacmhainne/na dtáibléad go randamach as iontrálacha a gheofar de réir na dTéarmaí agus Coinníollacha seo.
7. Gheobhaidh na buaiteoirí ceann de thrí rianaire corpacmhainne nó ceann de dhá tháibléad. Duais amháin an duine ar a mhéad.
8. Ní féidir fostaithe Chomhairle Cathrach na Gaillimhe na duaiseanna a bhuachan.
9. Tarraingeofar an Duais i mBealtaine / Meitheamh 2021, tar éis dhúnadh an tsuirbhé.
10. Cuirfear scéala chuig an mbuaiteoir leis na sonraí a cuireadh ar fáil sa suirbhé, tar éis an duais a tharraingt. Mura bhfreagraíonn an buaiteoir laistigh de 14 lá tar éis don GCC scéala a chur chuici/chuige, forghéillfear duais an bhuaiteora agus beidh GCC i dteideal buaiteoir eile a roghnú de réir an phróisis a thuairiscítear thuas. Beidh ar an mbuaiteoir seo freagra a thabhairt laistigh de 14 lá, nó forghéillfidh sí/sé an duais freisin. Má dhiúltaíonn buaiteoir do dhuais, nó má tá an iontráil neamhbhailí nó má sháraíonn sé na Téarmaí agus Coinníollacha seo, forghéillfear duais an bhuaiteora agus beidh GCC i dteideal buaiteoir eile a roghnú.
11. Ag brath ar na srianta Covid a bheidh i bhfeidhm tráth na duaise, is féidir socruithe maidir le postáil / seachadadh / bailiú a chomhaontú leis na buaiteoirí.
12. Foilseofar ainmneacha buaiteoirí an Chrannchuir Duaiseanna sna meáin lena n-áirítear ach gan a bheith teoranta do: Suíomh Gréasáin CCG; Suíomh Gréasáin Scoil Iognáid; Suíomh Gréasáin an Údarás Náisiúnta Iompair; Suíomh Gréasáin na Scoileanna Glasa; preaseisiúintí a eisítear go háitiúil agus go náisiúnta; cuntais meán sóisialta CCG lena n-áirítear Facebook, Twitter agus Instagram; ar raidió áitiúil / náisiúnta, ar na meáin chlóite agus ar láithreáin ghréasáin. Téarmaí agus Coinníollacha an Chrannchuir Duaiseanna

13. Ní féidir an duais a mhalartú, a aistriú ná a thiontú go hairgead nó do dhuais eile.
14. Leithdháilfear duaiseanna i gcomhréir le freagraí an tsuirbhé e.g. má thagann 75% de na freagraí sa suirbhé ó thuismitheoirí/chaomhnóirí, bronnfar 75% de na duaiseanna sa chrannchur ar an gcohort sin.
15. Coinníonn CCG an ceart duais eile den luach céanna a chur in ionad na duaise i gcás nach mbeidh an duais bhunaidh a tairgeadh ar fáil.
16. Tá an duais/na duaiseanna faoi réir théarmaí agus choinníollacha an mhonaróra nó an tsoláthraí agus tá gach barántas táirge, ráthaíocht nó uiríoll eile i ndáil leis an duais/na nduaiseanna faoi mar a fhaightear iad ón monaróir nó ón soláthróir. Ní bheidh CCG faoi dhliteanas as aon neamh-chomhoiriúnacht idir an duais/na duaiseanna le haon táirge nó seirbhís eile.
17. Próiseálfar d'fhaisnéis phearsanta de réir bheartas Cosanta Sonraí CCG. Gheofar faisnéis ar bheartas Cosanta Sonraí Chomhairle Cathrach na Gaillimhe [anseo](#).
18. Is ionann dul isteach sa Chrannchur Duaiseanna agus aontú gur féidir do chuid faisnéise pearsanta a bhailiú, a choinneáil, a úsáid agus a dháileadh chun d'iontráil sa Chrannchur Duaiseanna a phróiseáil agus scéala a chur chugat faoi, agus do na cuspóirí atá leagtha amach sna Téarmaí agus Coinníollacha seo.
19. Ní ghlacfaidh CCG aon fhreagracht as aon damáiste, caillteanas, dliteanais, gortú nó díomá a thabhoíd tú nó a fhulaingeoidh tú mar thoradh ar dhul isteach sa Chrannchur Duaiseanna nó duais a ghlacadh.
20. Forchoimeádann CCG an ceart ag am ar bith agus ó am go ham an Crannchur Duaiseanna seo a mhionathrú nó a scor, go sealadach nó go buan, le fógra roimh ré nó gan é mar gheall ar chúiseanna nach bhfuil faoina smacht (lena n-áirítear, gan teorainn, i gcás calaoise réamh-mheasta, amhrasta nó iarbhír). Beidh cinneadh CCG i ngach ábhar atá faoina rialú críochnaitheach agus ceangailteach agus ní bheidh aon chomhfhreagracht ann.

Téarmaí agus Coinníollacha an Chrannchuir Duaiseanna

21. Ní bheidh CCG faoi dhliteanas duit má fhulaingíonn tú aon chaillteanas nó damáiste trí dhul isteach sa chrannchur (lena n-áirítear aon chaillteanas indíreach, pionósach, speisialta, eiseamláireach, teagmhasach nó iarmhartach, caillteanas brabúis, caillteanas ioncaim, caillteanas cáilmheasa a eascraíonn as do rannpháirtíocht sa chrannchur nó i dtaca leis) nó ónár ndíúltú cead a thabhairt duit páirt a ghlacadh sa chrannchur nó ár dtarraingt siar den chrannchur nó aon teip nó neamhábaltacht eile uait maidir le páirt a ghlacadh sa chrannchur nó leas a bhaint as ar chúis ar bith. Ní dhéanann aon ní sna téarmaí agus coinníollacha seo ár ndlíteanas i leith díobhála pearsanta nó báis de bharr ár bhfaillí, nó calaoise, a eisiámh nó a theorannú.
22. Tá na rialacha faoi réir dhlí na hÉireann agus is ionann dul isteach sa chrannchur seo agus glacadh le dlínse eisiach chúirteanna na hÉireann.
23. **Dearbháin Tae / Caife** – gheobhaidh an chéad 100 freagróir ar na suirbhéanna Pobail / Tuismitheoirí & Caomhnóirí le chéile dearbhán le haghaidh tae nó caife saor in aisce. Is féidir an dearbhán seo a fhuascailt i gceann de na gnólachtaí seo a leanas in The Westend: The Secret Garden, Urban Grind, The Gourmet Tart, An Tobar Nua, nó Arabica (Sráid Dhoiminic). Ní féidir na dearbháin a aistriú agus ní mór iad a thaispeáint i ngnólacht cháilithe faoin 30 Meitheamh 2021.
