### **VESTING ORDER**

**SERIAL NO. GCC-VO-2024-004**

**WHEREAS** the land described in the Schedule hereto and shown on the maps attached hereto which said maps have been marked by reference to Vesting Order Serial Number GCC-VO-2024-004 and sealed with the seal of the Galway City Council (hereinafter referred to as "the housing authority") is land to which the Galway Corporation (Lands At Ballinfoile, Glenanail, Ballybaan Beg, Ballybaan More And Ballybrit Townlands) Compulsory Purchase Order No.1 1985 (Roads) relates, and the said order has become operative in so far as it relates to the said land:

**AND WHEREAS** the housing authority have, at least six months prior to the date of this order, entered on and taken possession of the said land in accordance with the powers conferred upon them by section 80 of the Housing Act 1966, as applied by section 10 of the Local Government (Ireland) Act 1898, as amended, section 76 of the Third Schedule to the Housing Act 1966 as extended and applied by section 10 of the Local Government (No.2) Act 1960 as substituted by section 86 of the Housing Act 1966:

**AND WHEREAS ---**

- (a) the several interests in the said land have not been conveyed or transferred to the housing authority,
- (b) the housing authority consider that it is urgently necessary, in connection with the purposes for which they have been authorised to acquire the land compulsorily, that the acquisition of the land should be completed, and
- (c) the housing authority have made a proper offer in writing to each person having an interest in the said land who has furnished sufficient particulars of his interest to enable them to make a proper offer for such interest:

**NOW THEREFORE** the housing authority in exercise of the powers conferred upon them by section 81 of the Housing Act, 1966, as applied by section 10 of the Local Government (No.2) Act 1960 as substituted as aforesaid, hereby order that the said land shall, on the 15<sup>th</sup> day of July 2024 **VEST** in the housing authority in fee simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind (other than any public right of way).

#### **SCHEDULE**

**ALL THAT AND THOSE** the land comprising the roads and footpaths on the N6 Bothar na dTreabh Road together with the adjoining lands situated in Ballinfoile, Glenanail, Ballybaan Beg, Ballybaan More and Ballybrit townlands in the City and County of Galway comprising 4.4154 hectares as more particularly delineated and outlined in blue and cross hatched blue on the attached maps dated the 27<sup>th</sup> day of May 2024 bearing map numbers A30-137(1 of 3); A30-137(2 of 3) and; A30-137(3 of 3) **AND** thereon marked with the numbers 1, 2, 3, 4, 7, 9, 10, 11, 13, 18, 19, 22.
