NOTICE OF PROPOSED DEVELOPMENT

APPLICANT: Galway City Council

SITE ADDRESS: Keeraun, Ballymoneen Road, Galway.

Pursuant to the requirements of Section 177AE(4)(a) of the Planning and Development Act 2000 (as amended) notice is hereby given that Galway City Council proposes to seek approval from An Bord Pleanála to carry out the following development at Keeraun, Ballymoneen Road, Galway.

Nature of Development: To construct a social housing development of 71no. units comprising – 4no. 1-bedroom units, 34no. 2-bedroom units, 22no. 3-bedroom units, 3no. 4-bedroom units, and 8no. TAA (Traveller Appropriate Accommodation) units, associated carparking and bicycle parking, green spaces & landscaping, connection to existing services and all ancillary/enabling site development works.

A Natura Impact Statement has been prepared in respect of the proposed development. An Environmental Impact Assessment Screening Report has been undertaken in respect of the proposed development and concluded that an Environmental Impact Assessment Report is not required. An Bord Pleanála may give approval for the development with or without conditions or may refuse the application for development. Plans and particulars of the proposed development together with the Natura Impact Statement and Environmental Impact Assessment Screening Report will be available for inspection, free of charge, at Galway City Council, City Hall, College Road, H91 X4K8 between the hours of **9:30 a.m. and 1:00 p.m. (BY APPOINTMENT ONLY)** from Monday to Friday (excluding Public Holidays) for a period from Monday 6th September 2021 to Monday 18th October 2021.
