Tá Comhairle Cathrach na Gaillimhe ag glacadh le hIarratais ar Scéim 2025 chun Aghaidh Siopaí a Fheabhsú, atá dírithe ar tharraingteacht shráid-dreocha trádála na Gaillimhe a fheabhsú agus athbheochan a dhéanamh orthu.

With a total fund of €200,000, this scheme offers financial support to eligible independent businesses in the Retail and Hospitality sectors to enhance their shopfronts through restoration, accessibility improvements, artistic collaboration, and more.

Who Can Apply?

- Independent retail and hospitality businesses with street-facing premises located within the boundaries of the three Architectural Conservation Areas (ACA) - City Core ACA, Lower Dominick Street ACA and Eyre Square ACA.
- Owners or leaseholders (with landlord consent).
- Businesses compliant with commercial rates and planning regulations.

Eligible Works Include

- Shopfront repairs and painting
- Bilingual signage (Irish and English)
- Accessibility upgrades
- Collaboration with local artists and craftspeople
- Conservation of heritage buildings
- Decluttering and greening initiatives
