Proposal:
In accordance with Part XI of the Planning and Development Acts 2000 (as amended) and Part 8, Article 81 of the Planning and Development Regulations 2001 to 2024, Galway City Council gives notice that it intends to carry out the following development at Cappagh Road, Knocknacarra, Galway.

The Development will consist of a Proposed Social and Affordable housing development on 2 connected sites at Cappagh Road, Galway City, consisting of:

Ba cheart a thabhairt ar aird go bhfuil feidhm ag an Acht um Shaoráil Faisnéise maidir le gach tairfead atá i seilbh Chomhairle Cathrach na Gaillimhe.

Beidh gach tuairim, lena n-áirítear ainmneacha na ndaoine a thugann tuairimí, a chuirfear faoi bhráid na Comhairle maidir leis an scéim seo mar chuid den tuarascáil atá riachtanach go reachtúil a chuirfear i láthair ag cruinniú na gComhairtáí Tofa.
