De bhun cheanglais Alt 177AE(4)(a) den Acht um Pleanáil agus Forbairt 2000 (arna leasú) tugtar fógra leis seo go bhfuil cead pleanála á lorg ag Comhairle Cathrach na Gaillimhe ón mBord-Pleanála d'uasghrádú agus d'fheabhsú Pháirc Cé na Coille agus an réimse poiblí máguaird atá suite ar Bhóthar an R866, Bharr an Chalaigh, Cathair na Gaillimhe, Co. na Gaillimhe.

Cuimsíonn an fhorbairt a bheartaítear:

- Uasghrádúithe agus leathnú ar pháirc Barr an Chalaigh lena n-áirítear soláthar;
- Tírdhreachú crua agus bog lena n-áirítear gairdíní báistí, áiteanna súi, tírghné sùgartha nádúrtha, agus plandáil móineir Mollina, bleibíní earraigh, sraitheanna fála agus cludach talún;

- Boscaí Bruscair;
- Bolardaí;
- Imeachtaí Solúbtha agus Limistéar Spás Oscailte;
- Soilsiú Poiblí Feabhsaithe;
- Bainistíocht feabhsaithe uisce dromchla bunaithe ar SuDS;
- Athlonnú cuimhneacháin ICA atá ann cheana; agus
- Gach obair ghaolmhar agus choimhdeach eile;

- Soláthar 4 uimh. trasrianta coisithe lena n-áirítear 2 uimh. trasna Cois Abhann, 1 uimh. trasna Cois Uisce, agus 1 uimh. trasna Ardán na Coiribe;
 - Tírdhreachú crua agus bog in aice leis an bpáirc (trasna Cois Abhann) chun fearann poiblí feabhsaithe a sholáthar lena n-áirítear: soilsiú poiblí, gairdín báistí draenála, limistéir súi, agus gach oibreacha gaolmhara agus coimhdeacha eile;
 - Páirceáil feithicle comhdhéanta d'athlonnú 2 uimh. Spásanna páirceála EV, athlonnú 2 uimh. spásanna páirceála inrochtana, coinneáil thart ar 10 uimh. ar spásanna páirceála sráide ar Ardán na Coiribe le mionathruithe ar thrasbhealaí nua do choisithe, agus 4 uimh. spásanna gluaisrothar. Is glanbhaint é seo de 11 uimh. spásanna gluasteán atá ann cheana féin.
 - Tírdhreachú crua agus bog in aice leis an bpáirc (trasna Cois Uisce) chun leanúint den chineál pábhála, cosáin níos leithne, soilsiú feabhsaithe, agus dearadh comhsheasmhach an fhearainn poiblí a chumasú;

 - Diúltú an cead a dheonú.

NOTICE IS HEREBY GIVEN that Galway City Council proposes to make an order closing:

New Street West: From the junction of Henry Street to the junction of Small Crane.

Period of Closure: 24/7 From 8.00am Monday 7th October 2024 to 8.00am Friday 11th October 2024.

Reason: To facilitate a new water connection for house development.

Diversion Routes: Temporary diversion route will be in place via St. Joseph's Avenue, Henry Street, William Street West and Small Crane.

Localised access will be maintained at all times.

Advance diversion signage will be in place prior to work commencing.

PLANNING & DEVELOPMENT ACT 2000 (AS AMENDED)
NOTICE OF PROPOSED DEVELOPMENT

Pursuant to the requirements of Section 177AE(4)(a) of the Planning and Development Act 2000 (as amended) notice is hereby given that Galway City Council is seeking planning permission from An Bord Pleanála for the upgrade and enhancement of Woodquay Park and surrounding public realm located on the R866 Road, Woodquay, Galway City, Co. Galway.

The proposed development consists of:

- Upgrades and expansion of the Woodquay park including the provision of:
 - Hard and soft landscaping including rain gardens, seating areas, natural play landform, and planting of Mollina meadow, spring bulbs, hedge row, and ground cover;
 - Removal of 1 no. 'Class C', and 1 no. 'Class B' trees. Planting of 4 no. new 'Golden Alder' trees;
 - Relocation and reduction in size of existing bike share station;
 - Galway Orb Sculpture and Light Feature;
 - Litter Bins;
 - Bollards;
 - Flexible Events and Open Space Area;
 - Enhanced Public Lighting;
 - Enhanced SuDS based surface water management;
 - Relocation of existing ICA memorial; and
 - All other associated and ancillary works;
 - Provision of 4 no. pedestrian crossings including 2 no. across Riverside, 1 no. across Waterside, and 1 no. across Corrib Terrace;
 - Hard and soft landscaping adjacent to the park (across Riverside) to provide enhanced public realm including: public lighting, drainage rain garden, seating areas, and all other associated and ancillary works;
 - Vehicular parking consisting of relocation of 2 no. EV parking spaces, relocation of 2 no. accessible parking spaces, retention of approx. 10 no. on street parking spaces on Corrib Terrace with modifications for new pedestrian crossings, and relocation of 4 no. motorcycle spaces. This is a net removal of 11 no. existing car spaces.
 - Hard and soft landscaping adjacent to the park (across Waterside) to enable a continuation of paving type, wider footpaths, enhanced lighting, and consistent public realm design;
 - All other associated and ancillary development and site works.
- A Natura Impact Statement (NIS) has been prepared in respect of the Proposed Development. Plans and particulars of the proposed development and the Natura Impact Statement can be viewed and will be available for inspection or for purchase for a fee not exceeding the reasonable cost of making a copy, for a period of 6 weeks (excluding bank holidays) from 27/09/2024 until 11/11/2024, at the following locations:

Submissions or observations may be made only to An Bord Pleanála ("The Board") 64 Marlborough Street, Dublin 1, not later than 5:30pm on 11/11/2024 relating to the following:

- the implications of the proposed development for proper planning and sustainable development in the area concerned,
 - the likely effects on the environment of the proposed development, and
 - the likely significant effects of the proposed development on a European site
- The Board may in respect of an application for permission decide to:

- (i) Grant the permission, or (ii) make such modifications to the proposed development as it specifies in its decision and grant permission in respect of the Proposed Development as so modified, or (iii) grant permission in respect of part of the proposed development with or without specified modifications of it of the foregoing kind and any of the above decisions may be subject to or without planning conditions, or
 - Refuse to grant the permission.
- Any person may question the validity of any such decision by way of an application for judicial review, under Order 84 of the Rules of the Superior Courts (S.I. no. 15 of 1986, as amended by S.I. No. 691 of 2011), in accordance with section 50 of the Planning and Development Act 2000 (as amended).
